Student Ombudsman Student Ombuds Services

- Ombud provides a resource for all the students for any kind of difficulty they are facing. This resource is informal and confidential. International Students can contact SOS with experiences or questions and will take appropriate action to help.
- Isolation was an issue before Covid but after the Covid issue of Isolation became worse. Contacting the Counseling Center at NC State is beneficial. There are some limitations to the Counseling Center because there are laws on action they can take outside of North Carolina and the United States.
- Council Member: What is the difference between the ombud and the Counselling center?
- Speaker: The counseling center has trained therapists for assisting students whereas SOS does not have mental health professionals. Ombud helps in making decisions about difficulties that you are facing whereas, the counseling center is more about mental health and they handle it professionally.

 - **Speaker:** So my current role is a little different than say my previous role when I was the Associate Vice Provost student leadership and engagement. I don't deal with policymaking for the university directly but he delivers the problem to the people who make the policies and can help the students to pass their concerns to the authorities that have the power to change the university Policies. Keeping international students in mind when leadership makes decisions about the university is part of the job.
